
# LITTLE DUNMOW PARISH COUNCIL

# 24/89. MOORS FIELD DEVELOPMENT/COMMUNITY BUILDING.

A report of the meeting held on 5 April with Dandara was given; there was an issue with getting drawings of the building done as the type of building still hasn't been decided and will depend on available funding, it will be discussed at the next Trustee meeting. The re-routing of the footpath near Brights Cottage is in hand. A problem with flooding to a neighbouring property was reported and Dandara will do what they can to rectify the problem.

**Road closures** - a sign giving notice of Station Road being closed for six weeks has been removed as permission has not yet been given.

**Development name -** Dandara has invited the Parish Council to submit some suggested names for the new roads. Residents will be consulted, Moors Field was put forward and it was also suggested that the names of surrounding fields could be used.

It was agreed to use the Meeting Room to sell refreshments to the footballers and their parents. The funds will go to the Little Dunmow Community Buildings Trust with a contribution to the Parish Council for use of the facilities.
