
LITTLE DUNMOW PARISH COUNCIL



Minutes of a meeting of Little Dunmow Parish Council held on Monday 8 July 2024 at 7.30pm at the Community Meeting Room, Brook Street, Little Dunmow.

24/24. APOLOGIES FOR ABSENCE.

24/25. MINUTES OF THE LAST MEETING.

The minutes of 10 June 2024 were approved as a correct record of events. **Proposed: Clir Westbrook. Seconded: Clir Clark. All agreed.**

24/26. PROGRESS CHECK.

Cllr French and Cllr Clark declared an interest in agenda item 24/30 as members of the Little Dunmow Community Buildings Trust.

24/28. PUBLIC FORUM.

There were no members of the public present.

24/29. REPORTS.

County Council - Cllr Foley was asked about the road closures currently in place and due at the end of August. The road closure means Little Dunmow is completely missed out of the 133 bus service (Arriva). The full closure at the end of August is due to utility work and a traffic light system is not possible due to legal restrictions. Compensation was discussed and this could be explored at the Public Meeting at the end of July. Flooding in Mill Road is a topographical problem and is being looked at. Station Road speed limit; once the development has finished speed surveys will be done and 30mph advisory limits on the bends could be a possibility.

District Council - Cllr Criscione updated the Council on the Draft Local Plan, the Regulation 19 version is now available to view and will go out for consultation, Cllr Criscione will support the Plan in its current form with development in the most sustainable locations.

Moors Field development - discharge of conditions has been refused by UDC as work was started before permission was given (it was noted that there were no material considerations given as a reason for refusal) and the developer must now stop work until this is resolved. Cllr Criscione offered his help and advice in a personal capacity with the new Community Building.

24/30. MOORS FIELD DEVELOPMENT.

Community Building Ownership - various options were discussed, more information is needed before a decision is made.

Open Space Ownership - it was agreed that the Parish Council would not take on ownership of the Open Space and that it should be handed over to a Management Company.

Proposed: Cllr Westbrook. Seconded: Cllr French. Unanimously agreed.
