#### 25/75. MINUTES OF THE LAST MEETING.

## 25/76. PROGRESS CHECK.

Station Road Safety - Flitch Green are asking for some form of traffic calming in Station Road following a fatal accident. Little Dunmow Parish Council will write to Essex Highways asking for a 30mph speed limit and some proper barriers at the site where the accident happened.

## 25/79. REPORTS.

County Council - no report received.

**District Council** - Cllr Criscione is now the Chairman of UDC. The Local Plan examination begins on 10 June, once it is adopted it lasts for five years, it will eventually be overruled by the new Unitary Authority. Uttlesford will probably be grouped with Epping Forest and Harlow, possibly Chelmsford as the new Unitary. With regard to planning UDC were designated under powers that restricted planning abilities, they have now been de-designated.

## 25/80. PLANNING.

**Application No: UTT/25/0732/FUL.** Proposed erection of four-bedroom dwelling with associated operational development.

**Location:** The Old School House, The Street, Little Dunmow CM6 3HT. **Approved with conditions.** 

A new application for agricultural barns just off the old A120 will be coming in soon, the Parish Council will discuss it once the application is received.

**Stansted Airport** planning application for Airfield works comprising two new taxiway links to the existing runway (Rapid Access Taxiway and Rapid Exit Taxiway) to enable continued airfield operations of 274,000 aircraft movements and

an increase in passenger throughput from 43 million terminal passengers to up to 51 million terminal passengers, in a twelve month calendar period. **Next agenda.** 

## 25/81. PARISH BOUNDARY WITH FLITCH GREEN.

To discuss the suggestion that Flitch Green Parish Council are considering asking Uttlesford District Council to change the boundary to include the recently granted 72 homes near Baynard Avenue in Flitch Green Parish. Various views on the pros and cons were given. If Flitch Green were to proceed with this proposal Little Dunmow Parish Council would not object, 4 councillors voted in favour of this proposal.
