12/44. ELECTION OF CHAIRMAN.

Cllr Atherton nominated Cllr Thomas as Chairman, this was seconded by Cllr Dodkins

Cllr Kerr gave an update on the current situation, the main issue seems to be that Dunmow Skips do not comply with anything they are required to do. The Parish Council continues to monitor the situation and Cllr Kerr liaises with the various authorities to ensure that any planning requirements are enforced. No interim meeting was held as communication with residents had sufficed.
