15/96. MAGNA CARTA CELEBRATIONS 2015.

A free parchment has been received which must be framed to a museum standard.

15/98. INFORMATION EXCHANGE / NEXT AGENDA ITEMS ONLY.

It was noted that the application for the 750 homes in Little Dunmow had been refused for the following reasons:

- The proposed development represents an inappropriate form of development within a rural area.
- The proposals would result in substantial harm to the setting of the Little Dunmow conservation area and listed buildings.
- The proposals fail to adequately consider the potential impacts in respect of ecology.
- The scale of the proposals is not compatible with the surrounding area.

- The proposals have not adequately demonstrated that they are acceptable in terms of their impact on highway safety and the highway network.
- The residential development of this site would increase the pressure on local infrastructure including education, healthcare and recreational facilities within the district.
