Application No: UTT/18/2609/FUL. Application to vary condition 2 (archaeology) from planning permission UTT/15/2318/FUL to revise layout to remove area of archaeological interest to enable development to take place.

Location: Bumpstead Hill, land west of A120, Chelmsford Road.

Application No: UTT/18/2600/FUL. Proposed demolition of the existing 12 bungalows on the site, and replacement with 16 new fit for purpose dwellings (8 x 1B2P Flats and 8 x 2B4P)

Location: The Moors, Little Dunmow.

Although the Council does not object to replacing the 12 bungalows with 16 small family homes, the provision of 8 flats is inappropriate for the area. A detailed response to be sent to UDC planning department.

Gladman Developments Ltd. Proposed Residential Development at land off Station Road. They are currently at the pre-application stage and are planning to submit an outline planning application. The site falls within Little Dunmow Parish. It was agreed to liaise with both Flitch Green and Felsted Parish Councils in opposing this application.
